CIRCULAR LETTER NO. 869

TO: THE BUSINESS MANAGER AND/OR FINANCIAL SECRETARY OF ALL AFFILIATED OUTSIDE, REGIONAL, SHOP AND NAVY YARD RIGGER LOCAL UNIONS

Dear Brothers and Sisters:

This is to advise that in accordance with the authority provided in Article XVI, Section 2a of the International Constitution, the General Executive Council met and considered increasing the Per Capita Tax rate for all members of this International Association.

The General Executive Council unanimously voted to increase the Per Capita Tax effective January 1, 2019 in the amount of One Dollar (\$1.00) per member per month for Outside and Regional members and Fifty Cents (\$.50) per member per month for Shop and Navy Yard Rigger members.

It should be noted that this increase does not need the approval of the membership and should be automatically implemented effective January 1, 2019.

Attached you will find a breakdown of the cost of the official dues receipts as of January 1, 2019 for all categories of Outside and Regional members, as well as all categories of Shop and Navy Yard Rigger members, which is self-explanatory and for your information.
